Focus of training programs at GWC

A planned curriculum to ensure that formal learning helps the personnel acquire the skills and knowledge they need

A focus on the right experiences, to put knowledge into practice and develop new skills; and

To meet the objectives, in addition to the ICAI CPE requirement, we have a mandatory learning policy, applicable to all client serving professionals. Minimum requirement is 60 hours every year of which 48 hours of the minimum learning should be in technical subjects.

Quality reviews

Measuring your satisfaction

Insider trading compliance

The quality policies also mandates insider trading compliances which reaffirms audit team's obligation not to trade in any securities while in possession of material, non-public information. The policy also requires that the audit team members do not disclose non-public information to others. An annual confirmation is taken from the team members in order to agree and adhere to this policy

Data privacy

The personal data privacy policy sets out the principles to be applied to the use and protection of personal data, including that relating to current, past and prospective personnel, clients, suppliers and business associates. This policy is consistent with applicable laws and regulation concerning data protection and privacy when processing personal data. It provides a foundation for maintaining the privacy of all personal data used by GWC.
